1 TO THE SUPERIOR COURT OF THE STATE OF CALIFORNIA:

2 WHEREAS, under the Settlement Agreement in this matter, which is incorporated by
3 reference into the Final Approval Order and Judgment (filed 4/10/20), ¶ 1, Settlement
4 Administrator ARCHER Systems is responsible for "Contracting with a VEBA Trustee, subject to
5 Court approval, and determining appropriate plan design for issuance of Supplemental
6 Payments to be distributed by the VEBA," Settlement Agreement, ¶ VIII-A-(ix); and

8 WHEREAS, the Settlement Agreement further provides that "The VEBA Trustee shall be
9 responsible for the following: (i) Serving as trustee of the VEBA pursuant to the terms in the
10 VEBA Trust...", id. ¶ VIII-B-1-(i); and

12 WHEREAS, ARCHER proposes to retain ARGENT Trust as the VEBA Trustee, see
13 accompanying Declaration of Blake A. Deady, ARCHER Systems, and


15 WHEREAS, Petitioners have informed Court Monitor Hon. Maria-Elena James and UC


